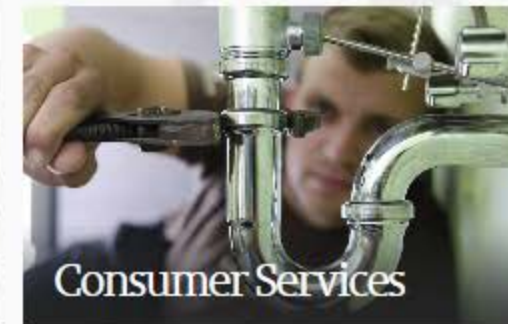

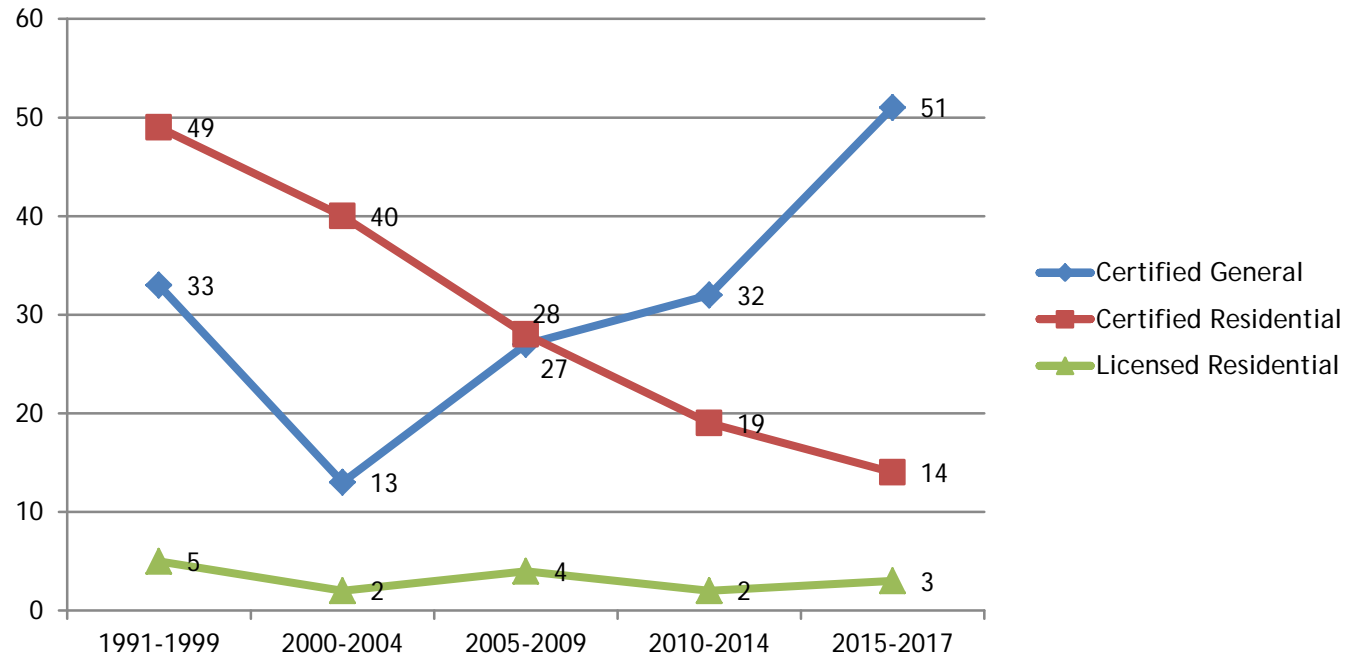

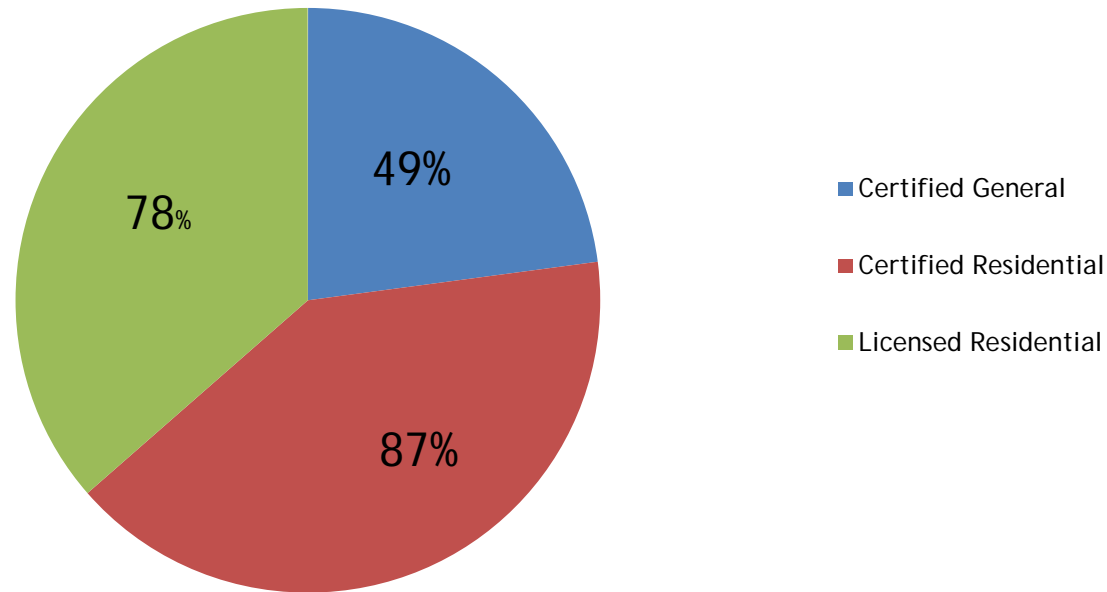
# Tennessee Licensing Data:
