<b>Sponsor Member:</b> This category is open to organizations providing appraisal services and having interest in real estate and appraisal and who support the objectives of NAA.	\$250
Emeritus Member: An individual who has held the Designated Member status for at least five years, is over the age of sixty-five, but is no longer active in the valuation profession.	\$50
<b>Individual Affiliate:</b> An individual who may not be engaged in the appraisal profession but has interests in appraising and is in agreement with the objectives of the NAA. <u>Individual Affiliates are not eligible to serve on the Board of Directors.</u>	\$50
Industry Affiliate: Appraisal Companies, Appraisal Management Companies and Mortgage Lenders.  Industry Affiliates are not eligible to serve on the Board of Directors.	\$200
